DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR THE PROCUREMENT OF NETWORK SECURITY AND IP ACCESS MANAGEMENT SYSTEM FOR THE BUREAU OF THE TREASURY / ITB-4-2025-G EPA

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Procurement of Network Security and IP Access Management System for the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Four Million Two Hundred Thousand Pesos (PHP 4,200,000.00), inclusive of all applicable taxes;

WHEREAS, on October 8, 2024, the Invitation to Bid (ITB) No. 4-2025-G EPA was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on October 16, 2024, five (5) prospective bidders, namely, 1) AGD Infotech, Inc., 2) APT Secure Technologies, Inc., 3) Versatest Solutions and Services, Inc., 4) First Data Corp., and 5) A.G. Datacom Phils., Inc., attended the Pre-bid Conference;

WHEREAS, on October 22, 2024, Supplemental Bid Bulletin No. 08-2024 was issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

WHEREAS, on October 29, 2024, only one (1) bidder, AGD Infotech, Inc., submitted its technical and financial proposals through the e-bids@treasury.gov.ph;

WHEREAS, on October 29, 2024, the submitted Technical and Financial Bids were opened, read, and calculated as follows:

WHEREAS, pursuant to Resolution No. 20-2024 dated October 29, 2024, the BAC declared AGD Infotech, Inc., as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by AGD Infotech, Inc., the BAC found the same to be responsive and recommends the award of the contract to AGD Infotech, Inc.;
