**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR
THE PREVENTIVE MAINTENANCE FOR THE VARIOUS AUDIO-VISUAL (AV)
SYSTEM FACILITIES OF THE BUREAU OF THE TREASURY / ITB-5-2025-G EPA**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Preventive Maintenance for the Various Audio-Visual (AV) System Facilities of Bureau of the Treasury with an Approved Budget for the Contract (ABC) of One Million Nine Hundred Fifteen Thousand Pesos (PHP 1,915,000.00), inclusive of all applicable taxes;

WHEREAS, on October 8, 2024, the Invitation to Bid (ITB) No. 5-2025-G EPA was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on October 16, 2024, only one (1) prospective bidder, JMS Technology and Supplies, attended the Pre-bid Conference;

WHEREAS, on October 29, 2024, only one (1) bidder, JMS Technology and Supplies, submitted its technical and financial proposals through the e-bids@treasury.gov.ph;

WHEREAS, on October 29, 2024, the submitted Technical and Financial Bids were opened, read, and calculated as follows:

WHEREAS, pursuant to Resolution No. 21-2024 dated October 29, 2024, the BAC declared JMS Technology and Supplies, as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by JMS Technology and Supplies, the BAC found the same to be responsive and recommends the award of the contract to JMS Technology and Supplies;
