DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB) FOR THE SUPPLY, DELIVERY, INSTALLATION AND CONFIGURATION OF RACKMOUNT SERVERS FOR PRIMARY AND SECONDARY SITES/ ITB-6-2025-G EPA

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply, Delivery, Installation, and Configuration of Rackmount Servers for Primary and Secondary Sites with an Approved Budget for the Contract (ABC) of Six Million Pesos (PHP 6,000,000.00), inclusive of all applicable taxes;

WHEREAS, on October 9, 2024, the Invitation to Bid (ITB) No.06-2025-G (EPA) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on October 17, 2024, seven (7) prospective bidders, namely, 1) Integrated Computer System, Inc., 2) Sandz Solutions Philippines, Inc., 3) Joneco Tech Marketing Corp., 4) Accent Micro Technologies, Inc., 5) Banbros Commercial, Inc. 6) American Technologies, Inc., and 7) Questech Co., Inc., attended the Pre-bid Conference:

WHEREAS, on October 23, 2024, Supplemental Bid Bulletin No. 09-2024 was issued to modify/amend items in the Bid Documents, in response to the gueries and clarifications made during the Pre-Bid Conference;

WHEREAS, on October 30, 2024, three (3) bidders, 1) Sandz Solutions Philippines, Inc., 2) Integrated Computer Systems, Inc., and 3) Questech Co., Inc., submitted their technical and financial proposals through e-bids@treasury.gov.ph;

WHEREAS, on October 30, 2024, the submitted Technical and Financial Bids were opened, read, and calculated as follows:

WHEREAS, after verification, due consideration and deliberation it was determined that Questech Co., Inc. was declared ineligible due to non-compliance/discrepancies such as the incongruence in the Single Largest Completed Contract (SLCC) requirement and the attached documents and the absence of a document certifying that the bidder has been operating in the Philippines for the last five (5) years as an I.T. company;

WHEREAS, pursuant to Resolution No. 22-2024 dated October 30, 2024, the BAC declared Integrated Computer Systems, Inc., as the Lowest Calculated Bidder (LCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which, after a holistic review, examination, validation, and verification of all statements made and the legal, technical, and financial documents submitted by Integrated Computer Systems, Inc., the BAC found the same to be responsive and recommends the award of the contract to Integrated Computer Systems, Inc.;

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Integrated Computer Systems, Inc., as the Lowest Calculated and Responsive Bidder (LCRB) for the Supply, Delivery, Installation, and Configuration of Rackmount Servers for Primary and Secondary Sites;
- b. recommend the award for the Supply, Delivery, Installation, and Configuration of Rackmount Servers for Primary and Secondary Sites for the Contract Price of Four Million Five Hundred Twenty-Eight Thousand Nine Hundred Twenty-Four Pesos (PHP 4,528,924.00), inclusive of all applicable taxes; and
- c. recommend the foregoing for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE).
