### **CONTRACT AGREEMENT**

THIS AGREEMENT made on the 16th day of January 2025 between **BUREAU OF**THE TREASURY, with office address at Ayuntamiento Building, Cabildo Street corner Andres Soriano Avenue, Intramuros, Manila 1002 (hereinafter called "the Entity") of the one part and **RENPHIL TRADING** with office address at Unit 10 K-Plaza 22 Gen.

T. De Leon Road, Brgy. Karuhatan, Valenzuela City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids/Quotations for certain goods and ancillary services, particularly Supply of Labor and Materials for the Repair of the Air Handling System of Second Floor-Quadrant E, Fourth Floor-Quadrant B and Sixth Floor-Quadrant B of the Palacio del Gobernador Building and has accepted a Bid/Quotation/Proposal by the Supplier for the supply of those goods and services in the sum of <a href="PHILIPPINE">PHILIPPINE</a> PESOS: Nine Million Seven Hundred Twenty-Three Thousand Five Hundred Seventy-Six (PHP 9,723,576.00), inclusive of all applicable taxes, (hereinafter called "the Contract Price").

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
  - i. Philippine Bidding Documents (PBDs)<sup>1</sup>;

    - iv. Supplemental or Bid Bulletins, if any
  - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted<sup>3</sup>;

Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of PHILIPPINE PESOS: Nine Million Seven Hundred Twenty-Three Thousand Five Hundred Seventy-Six (PHP 9,723,576.00), inclusive of all applicable taxes, or such other sums as may be ascertained, RENPHIL TRADING. agrees to perform and deliver the "Supply of Labor and Materials for the Repair of the Air Handling System of Second Floor-Quadrant E, Fourth Floor-Quadrant B and Sixth Floor-Quadrant B of the Palacio del Gobernador Building" in accordance with his/her/its accepted Bid/Quotation/Proposal.
- 4. The **BUREAU OF THE TREASURY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding/Accepted Quotation/Proposal and procurement documents.
