DECLARING FAILURE OF BIDDING AND RECOMMENDING THE RE-BID FOR THE SUPPLY OF LABOR AND MATERIALS FOR THE REPLACEMENT OF CARPET TILES AT THE OFFICES OF THE AYUNTAMIENTO BUILDING / ITB-8-2025-G EPA

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply of Labor and Materials for the Replacement of Carpet Tiles at the Offices of the Ayuntamiento Building with an Approved Budget for the Contract (ABC) of Four Million Nine Hundred Ninety Pesos (PHP 4,990,000.00), inclusive of all applicable taxes:

WHEREAS, on October 9, 2024, the Invitation to Bid (ITB) No. 8-2025-G EPA was posted in the Philippine Government Electronic Procurement System (PhilGEPS), BTr website, and to BTr conspicuous places;

WHEREAS, on October 17, 2024, three (3) prospective bidders, namely, 1) Verizen Construction., 2) Showcase Carpet Center and Co., and 3) JEMN Builders, attended the Pre-bid Conference:

WHEREAS, on October 23, 2024, Supplemental Bid Bulletin No., 11-2024 was issued to modify/amend items in the Bid Documents, in response to the gueries and clarifications made during the Pre-Bid Conference;

WHEREAS, on October 30, 2024, no bidder submitted its bids and participated in the Opening of Bids thus, the BAC is constrained to declare a failure of bidding for the Supply of Labor and Materials for the Replacement of Carpet Tiles at the Offices of the Ayuntamiento Building;

NOW THEREFORE, the Bids and Awards Committee RESOLVED, as it hereby **RESOLVES** to:

- a. declare failure of bidding for the Supply of Labor and Materials for the Replacement of Carpet Tiles at the Offices of the Ayuntamiento Building;
- b. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings; and
- c. conduct re-bidding of this project.
