5. **Mayor's/ Business Permit & PhilGEPS registration number shall be attached upon submission of the quotation.**
6. Additional Documentary Requirement:
 - Certification from Manufacturer or Distributor that the Bidder is authorized to sell the consumables being offered.
7. Submission of pieces of evidence as proof of compliance with the bidder's offer, if applicable.
