SUBJECT:

Supplemental Guidelines to the Treasury Circular (TC) Nos. 03-2024 dated 12 April 2024 and TC 02-2022 dated 31 May 2022 in line with the implementation of the National Government Collection and Disbursement System (NGCDS) of the Bureau of the Treasury

1.0 LEGAL BASIS

This Circular is issued in accordance with Section 1, Item No. 2 of Executive Order No. 449, Series of 1997, which empowers the Bureau of the Treasury to formulate adequate guidelines for fiscal and financial policies, as well as Executive Order No. 55, Series of 2011, concerning current fiscal policy initiatives under the Public Financial Management Framework.

2.0 PURPOSE

This Circular is to supplement Treasury Circulars (TC) Nos. 02-2022 and 03-2024 to facilitate the realignment of existing systems and procedures of the Bureau regarding the depositing and reporting of various collections by the National Government.

3.0 GUIDELINES

- 3.1 To update the list of major clearing accounts maintained with Authorized Government Depository Banks (AGDBs), Section B. (1) General Guidelines of TC 02-2022, is hereby revised as follows:
 - "1. The Bureau of the Treasury (BTr) shall open and maintain **four (4)** major clearing accounts with Authorized Government Depository Banks (AGDBs) designated for the following types of funds to be utilized by all National Government Agencies (NGAs):

SOCOTEC SOCIETY OF THE PROPERTY OF THE PROPERT

- i. BTr- Regular Fund 1
- ii. BTr-NGAs Fees and Charges 1
- iii. BTr- Inter Agency Trust Fund (IATF)
- iv. BTr-Other than IATF
- 3.2 To provide the list of clearing accounts to be used for the Regular Fund collections of the Bureau of Internal Revenue (BIR) and Bureau of Customs (BOC) Section B General Guidelines (2) of TC 02-2022 is hereby revised as follows:
 - "2. The list of BTr clearing accounts "Annex B" for the **Regular Fund** collections of Bureau of Internal Revenue (BIR) and Bureau of Customs (BOC) with AGDBs shall be maintained and automatically swept to the designated BTr-BIR/BOC Mother account within the day."
- 3.3 To update the list of receipts and income and properly ascertain the fund classification for the collections to be remitted to the corresponding designated clearing accounts, Section C. (1) Deposit/Remittance of Collections is hereby revised as follows:
 - "I. Deposit/Remittance of Collection

The NGAs shall determine the appropriate fund classification of the collections for remittance, utilizing the corresponding clearing accounts assigned for each type of fund:

3.4 To amend provisions under the Remittance thru Electronic Banking Collection or E-Payment Section C (d) is revised to read:

" d. Remittance through Electronic Banking Collection/Digital Payment

The remittances executed via electronic/digital payment, encompassing but not limited to the following: Link.BizPortal, weAccess, eMDS, RTGS, and remittances through special tie-ups, are covered under Electronic Banking/ Digital Payment of Collections. Agencies may engage the services of established Payment Service Providers (PSPs) in accordance with Executive Order 170 s. 2022.

- "i. The BTr shall open and maintain a separate <u>parking account</u> with the AGDBs upon receipt of request from the NGAs for the electronic /digital payment mode supported with the copy of a Memorandum of Agreement and assign the designated destination major clearing account per type of fund."
- 3.5 To provide a more comprehensive report on the nature of collection, additional sub-section under Section C. II. Report of Collection is inserted to read:
 - "i. NGAs shall submit the monthly fees and charges collections with details or nature of the collections as listed under Annex A to the designated Google Shared Drive provided by the BTr (https://tinyurl.com/3r7n9rvz) no later than the tenth (10th) calendar day of the succeeding month.
 - "j. To assist BTr in validation and reconciliation of the submitted data, NGAs shall also submit a soft copy of their Quarterly Report of Revenue and Other Receipts (FAR No. 5) to this Bureau's National Cash Accounting Division and Fiscal Planning and Assessment Division and email to ncad@treasury.gov.ph and fpad@treasury.gov.ph no later than the 30th calendar day after the reference quarter.

4.0 REPEALING CLAUSE

All Circulars, orders, and/or memoranda issued by this Bureau which are inconsistent herewith are hereby repealed and/or modified accordingly.

5.0 EFFECTIVITY

This circular shall take effect immediately.
